## HIGHWORTH LIBRARY STAFFING ARRANGEMENTS - SERVICE LEVEL AGREEMENT (SLA)

60. The SLA is still under negotiation. A meeting is to be arranged with other local parishes that are also funding library hours and a second meeting to be arranged with SBC legal to discuss the details of the SLA.

### SHRIVENHAM ROAD PLANNING APPLICATION - REPORT

- 61. Shrivenham Road planning application was granted permission at the SBC Planning Committee meeting on Tuesday 10<sup>th</sup> October 2017. A number of Councillors attended the meeting to represent HTC views and to support the Neighbourhood plan. Section 106 money will be available and HTC has requested that this money be used towards 3 projects in Highworth:
  - Skate park
  - Re-surfacing The Rec car park/additional parking
  - Help with funding of new gymnasium equipment

There is also the possibility of CIL being available in the near future. HTC cannot appeal the planning decision but can try and ensure that these funds are directed towards Highworth.

A meeting is to be arranged with the Neighbourhood Plan Working Party and other urban parishes to discuss a joint strategy.

# **MAY DAY**

62. Resolved by Councillor K Smith and seconded by Councillor C Adams that HTC contribute £3500 to the May Day Festival to be held in 2018 seconded by Councillor C Adams. Councillors voted 13 for, 1 against and 1 abstention. The Resolution was duly carried.

### **CORRESPONDENCE**

63. a. The police have advised that the individual who caused damage to the chamber door has not agreed to a community resolution. Councillors unanimously agreed that they wanted to take this matter further and for the Town Clerk to approach members of the public to make a witness statement.

## **QUESTIONS FROM COUNCILLORS**

64. <u>Councillor K Smith.</u> Councillors were informed that there is not a protocol for the replacement of minor employees, such as cleaners. It was agreed that it is the Town Clerk's responsibility to employ a replacement cleaner so long as the post is suitably advertised. The decision as to whether this work should be by either a contract with an outside firm or by direct employment should be a value judgement for the Clerk. It was agreed that the Parking Attendant element of the post is now defunct.
