Highworth Town Council wish to comment on Policy DM32 as follows: -

Historic Environment

1. Swindon Borough's historic environment shall be sustained and enhanced. This includes all heritage assets archaeological remains, listed buildings, conservation areas, registered parks and gardens, scheduled monuments, as well as locally listed buildings and other non-designated heritage assets.

It is a shame that whilst it is recognised in paragraph 7.11.4 "the Market Town of Highworth is a notable resource containing a high proportion of listed buildings (over 80), many highly graded" Its importance has never been recognised until now. 7.11.8 Swindon Borough Council have constantly failed to survey the Town. Swindon Borough Council has covered the Conservation Area in black tarmac. Swindon Borough Council also allowed the deterioration of listed buildings in Swindon Street by failing to reduce the speed of traffic and failing to encourage HGVs to use an alternative route.

This planned expansion of 866 houses will have a very damaging effect on the nature of this Town, the highest Town in Wiltshire. Swindon Borough Council recognise that Highworth is a notable resource with a high proportion of listed buildings however its importance has not been recognised until now, yet Swindon

Borough Council agree in its appraisal to sites (230 entrance to the lower rec of Swindon Road), (477 the site next to the cemetery off Cricklade road) and (482 Shrivenham Road) will have disastrous effect on the Town's landscape. To add to that, Swindon Borough Council has already granted outline planning permission on site (482 Shrivenham Road LA19) for 50 more houses than it originally indicated.
