This site allocation has been approved by Swindon Borough Council pending the signing of a legal agreement. Highworth Town Council is very dissatisfied with this decision particularly as it does not meet the criteria Swindon Borough Council set out in this Policy even though it was supported with fundamental evidence. In particular criteria f) Highway improvements to secure school safety and capacity. The safety audit confirmed it was highly likely that there would be a collision between a pedestrian and a vehicle!

The allocation in the plan was for 200 houses although Swindon Borough Council have approved it for 250 houses. This is a 25% increase which is excessive particularly when it was identified that it would have an impact on Highway capacity along Shrivenham Road. The Fox Roundabout was identified in the Transport Report as functioning above capacity at peak times along with the traffic lights on Swindon Road. The cumulative impact of this development with 2 other live planning applications for 80 houses and 50 houses along Shrivenham Road which are not sites in this Plan will have a significant impact on the Highway network in terms of safety and congestion.

The landscape and conservation officer advised that the site would cause significant harm to the landscape and heritage assets. This list is by no means exhaustive.

Highworth Town Council felt so strongly about this result that they presented a case to the Secretary of State to call the application in.
